New Business:

*Show Committee Report. Categories we have decided on for our May Specialty show are: Showmanship, Hunter Under Saddle, Hunt Seat Equitation, Trail, Horsemanship, Western Pleasure and Longe Line (variance for Longe line was approved by APHA). We will offer applicable classes for Youth, Amateur, Novice Amateur, Solid Paint Bred and Open & All Breed. Flat fees.

*Clinic - Kip Larson Clinic scheduled for March 23-24 in Central Point. We released information to members and the public as of 2/15. As of meeting date, we had a few entries. Proceeds will be donated to Humanity for Horses.

*SEOPHC - Kristi spoke with Kristy Federico of SEOPHC about the details of NCPHC using their show as a qualifying show for year-end awards and vice versa. NCPHC will take the two best judges from their show. To qualify for a year-end award from SEOPHC, you will need to become a member of SEOPHC and pay the \$25 awards fee. No work hours will be required. Their show is scheduled for Sept 13-15th and the Triple Crown Futurities will also be held there.

*Year End Rules - Kristi & Jennifer will finalize our year end rules requirements and get them sent to Lauren to post on the website.

*Charity Show - NCPHC will be hosting the "SAVE THE FAIR" Charity Show on June 8 & 9th at the Siskiyou Golden Fairgrounds in Yreka, CA. With all the budget cuts, we want to help save the fairgrounds, where our annual two day two judge show is held. The fairgrounds will not charge us anything to use the facility and whatever proceeds are made, after covering our cost, will be earmarked for the horse facility.
